## Ekonomi Sarawak terus berkembang

KUCHING : Sarawak dijangka mengalami pertumbuhan ekonomi yang paling ketara dan berkembang sehingga 4 peratus pada tahun 2018, kata Menteri Perdagangan Antarabangsa dan E-Perdagangan dan Menteri Kewangan II, Dato Sri Wong Sook Koh.

Katanya, jangkaan ini adalah berdasarkan kemajuan besar dalam pembangunan ekonomi disamping bentambahan golongan Perusahaan Kecil dan Sederhana (PKS) di negeri ini.

Menurutnya, sehingga awal 2017 jumlah PKS yang berdaftar di negeri ini terus meningkat iaitu 62,000 berbanding hanya 43,800 PKS pada 2016.

"Ini jelas menunjukkan minat rakyat Sarawak dalam perniagaan tenus meningkat. Dan saya percaya terdapat masih ramai lagi PKS yang aktif tetapi belum berdaftar di luar sana."

Katanya. Beliau berkata demikian pada majlis perasmian Ceramah Perdagangan Perusahaan Kecil dan Sederhana sempena Festival Perusahaan Malaysia 2018 di sini semalam.

Teks ucapan beliau dibaca oleh Menteri Muda Pembangunan Usahawan Kecil dan Sederhana dan Menteri Muda E-Dagang, Datuk Mohd Naroden Majais.

"Wong berkata dalam era digital pada masa ini, semua PKS perlu sedar bahawa teknologi internet telah banyak mengubah cara dunia melakukan perniagaan, terutama dalam perniagaan maklumat."

Sehubungan itu, katanya, pergantian pada teknologi internet menjadi trend baru dan akan menjadi budaya kepada semua pengusaha dalam menjalankan perniagaan pada masa depan.

"Oleh itu, PKS harus belajar untuk memahami teknologi terkini dan menggunakan dalam usaha membantu meningkatkan diri dan taraf perusahaan masing-masing."

"Langkah ini amat pelu supaya PKS yang ada sekarang akan dapat bersaing dan mau setanding dengan syarikat-syarikat besar," katanya...

Wong berkata, Sarawak dibawah kepimpinan Ketua Menteri Datuk Patinggi (Dr) Abang Haji Abdul Rahman Zohari Tun Abang Openg telah memberikan penekanan yang besar dalam merumuskan strategi pembangunan yang akan meluaskan asas ekonomi negeri ini melalui perindustrian.

Katanya, dalam masa yang sama Sarawak akan terus membangun leburan peluruhan terutama dalam industri teknologi tinggi untuk menanam model pelurusan di negeri ini.

"Ini jelas tentang apa yang kita mahu untuk Sarawak dan rakyatnya. Pelan Transformasi Sosioekonomi Swak (SETP)

menyediakan prinsip panduan yang komprehensif tentang bagaimana kita mahu bergerak maju menuju negara atau rakyat yang pendapatan tinggi dan negara maju menjelang 2030."

Katanya, pengujudan

Koridor Tenaga Yang Boleh Dipertahankan (SCORE), sejak tahun 2008 adalah sebagai pemangkin dan peransang pertumbuhan pelurusan di Sarawak.

## SMEs contribute to 51% of state's GDP

KUCHING: Small and Medium Enterprises (SMEs) contribute to about 51% of the state's Gross Domestic Product (GDP). This year, the state's economy is expected to grow by 4 percent.

Minister of International Trade and E-Commerce, Dato Sri Wong

Soon Koh, stated this in his speech while officiating the TMEF SME business talk at Pullman Hotel here yesterday.

In his speech read by Assistant Minister of E-Commerce and Assistant Minister of Entrepreneur and Small, Medium Enterprise (SME) Development, Datuk Haji Mohd Naroden Majais, Wong

added: "In developing countries, SMEs have contributed tremendously to their GDPs and economic growth. They also help in employment, income and purchasing power of workers, income to government through taxes and tourism among others."

"By 2011, there were about 43,000 SMEs in Sarawak registered with SME Corporation. They increased to 62,000 at the beginning of 2012."

"This clearly shows that interest among Sarawakians in businesses has increased. I believe many more have still not registered out there. But SMEs have to understand now that the advancement of technology and internet has changed the way the world doing its businesses and the way information is exchanged."

Wong said SMEs should learn to understand the latest technologies and embrace them in order to strengthen and upgrade their businesses.

"Only in this way, SMEs can be at par with the big corporations as technologies and the internet can put the smaller companies on the same playing field as the bigger corporations. No matter where you are, whether you are in the big cities or in the interior and no matter how small or how big your investments are, technologies and internet will put you on the same playing field," he said.

Wong added that the selection of Sarawak as the venue was not by chance.

"The decision underscores the potential of this state to be a vibrant destination for companies to conduct business. Being the largest state, and endowed with rich natural resources, Sarawak offers multiple opportunities that have to be fully exploited and tapped by the business community."

He pointed out that Sarawak Socio Economic Transformation Plan (SETP) provided comprehensive guiding principles on how Sarawak wanted to move forward in becoming a high income and developed state by 2030.

Chief Minister, Datuk Patinggi (Dr) Abang Johari Tun Openg, Wong added, placed great emphasis on formulating development strategies that would broaden the

state's economic base through industrialisation.

"The establishment of Sarawak Corridor of Renewable Energy (SCORE) back in 2008 certainly acts as a catalyst to stimulate investment-led growth in Sarawak particularly in the Central Region."

Based on our core advantage, 10 priority industries have been identified for further development given their potentials in generating huge economic impacts to the state. They are aluminium, oil based, steel, glass, palm oil, timber based, livestock, agriculture, marine engineering and tourism industries.

"With the identification of these priority industries, the state government through its various agencies, particularly, the Regional Corridor Development Authority (RECODA) will intensify its efforts

in improving the required physical development as well as investment promotion and marketing for these industries," he added.

Wong praised the state government's effort in bringing Multinational Corporations (MNCs), Large Local companies (LLCs) and small and medium enterprises (SMEs) together for them to network and share insights and ideas towards building stronger supply chains in this region.

The presence of stronger supply chains here, he said, would in return make Sarawak a more attractive investment destination in the country.

"Rest assured that Sarawak government and agencies will work hand in hand with ministries and agencies at the federal level in realising this agenda," said Wong.
